<u>Sheep</u>- Kevin Pruess reported the judge and all 3 classifiers have been confirmed and everything is ready for show day. After discussion of the possibilities of not enough finewools to make a class of 5 as stated in the rulebook Kevin said they will go into the finewool cross classes and if there is not enough hair sheep they will go into the medium wool classes.

<u>Goat</u>- Lance Loerwald was not present however had reported to Cari Kleen by phone just before the meeting that reported the judge and the person to check for blocking have been confirmed and everything is ready for show day.

Rabbits- Joe Leopold reported the judge has been confirmed and everything is ready for show day.

<u>Turkeys</u>- Joe Leopold reported the judge and classifier have been confirmed and everything is ready for show day.

Broilers- Joe Leopold reported the judge and classifier have been confirmed and everything is ready for show day.
