 - All champions & reserve champions
 - Pull hair at conclusion of champion drive
 - Pull random test from showmanship classes
 - Retags (all) shall have DNA hair pulled
 - Any protest that is brought to the committee will be tested. Samples will be pulled after protest fee paid.
 - DNA Samples matched prior to checks being issued. All samples matched for 2023 show.
- Validation operations:
 - 2024 Steer Validation DNA samples will be pulled at state validation time that the county extension office sets. Need Rules Acknowledgment Forms filled out at same time. Alternate Housing Requests, if applicable, must be submitted minimum of two weeks prior to state validation for approval. Heifers will need to be state validated.
 - 2024 WCLA Validation will require all lambs and goats to purchase a WCLA tag if they didn't get a State Validation Tag for the State Fair of Texas. It is unknown when state validation tags will arrive to validate prior to the deadline
 - 2024 WCLA Show Market rabbit tattoo date to be major show entry night or last day of regular entry for WCLA. November 6, 2024.

- No Peewee class for 2024 breeding showmanship shows. Exhibitors must be between the ages of 9 (or 8 and in the third grade) and 19 years of age as of September 1, 2024 and have a quality counts number.
- We will have a future feeder's showmanship for market shows: Lambs, Goat, & Swine only.
- Photographer for 2024 - **MD Creations**.
- Animals need to be sheared / clipped prior to arriving, touch up is ok.
 - Steer heads needs to be clipped, specifically polled breeds.
 - British Breeds need to designate breed showing under.
- No Wire Halters of any kind on any species.
- Drug Testing: Look into hiring outside entity to administer, monitor and test. Set up teleconference or tour to research. Need to review guidelines and set rules.

Old Business

- 1) Turkey pick up was Thursday, 8/29/24.
- 2) Broiler orders closed August 30, 2024.
 - Broiler pickup will be Friday, November 1, 2024 at the Training Room.
- 3) WCLA Late tag orders opened September 16, 2024 and will close this Saturday, September 28, 2024.
 - The State lamb and goat validation committee has run out of state validation tags and it is unknown when they will arrive. Due to these unforeseen circumstances, we will allow late tag orders to occur up to 10 pm on October 4, 2024.
 - **Exhibitors participating in the Williamson County Livestock Show will be required to order a WCLA tag no later than Friday, October 4, 2024 at 10:00pm, unless you have already been state validated for the State Fair of Texas livestock show.**
 - Those who order tags after September 28, 2024, will need to bring their animal(s) to validation on October 5, 2024 to receive ear tag and validation paperwork. Emails and Facebook posts will be sent to notify everyone.
 - Retags will be done on site at any future lamb and goat state validation in the case a WCLA tag needs to be removed for tattooing.
- 5) Validation completion date for market lamb, goat and swine is October 5, 2024. Turn in of validation packets will occur at the pavilion behind the county extension office building from 8 am - 12 pm at 100 Wilco Way Georgetown, TX 78626.

- 6) **All projects must have WCLA or Texas State validated tag in the animals' ear and the tag number must be listed on the DNA envelope.**
 - The WCLA will assist or conduct a final validation for those who did not complete self-validation on October 5, 2024 from 8 am -12 pm. Those wanting to validate must be in line by 11am at back parking lot/pavilion of county extension office building.
- 7) Update on different judges for the breeding shows. Breeding Doe/Ewe judge is confirmed. Need to find Heifer and Breeding Swine.
- 8) Discussed WCLA Validation Compliance inspection of projects. Everything checked so far has been good.
- 9) Waiting on raffle tickets to be printed. Drawing will occur December 13, 2024 and prizes will be awarded the day of sale to the winners. Tickets will be \$25/ticket or 5 tickets for \$100.
- 10) WCLA fundraiser still being planned for April 12 or April 19 2025.
- 11) Discussed selling current 20' Conex containers and purchasing new 40' Conex containers to store pens and gates and box trailer for annual organizational and show office items. Need further discussions with storage location.

New Business

- 1) Validation deadline of Oct 5, had several show up to be tagged/validated, most just turned in DNA envelopes. A couple were sent via mail.
 - Discussion of issues regarding multiple tag numbers being allowed to validate. Only thing we can control is WCLA tags.
- 2) Broiler pickup will be Friday, November 1, 2024 at the Training Room.
- 3) Discuss scholarships still needing to be awarded. Missing 6 awardees info and will contact. Two sent have yet to be processed and will be reassessed.
- 4) First lamb and goat state validation had a lot of animals come through to be state validated. Retagged one goat that pulled WCLA tag out and collected DNA on site while it was being state validated. Didn't have to retag any due to insufficient ear space for tattoo.
- 7) Update on different judges for the breeding shows. All judges confirmed; awaiting signed contracts.
- 8) Discuss Alternate Housing Request forms.
 - Blake Henderson made a motion to accept the 2 alternate housing request forms on the table. BJ Simpson seconded. Motion was unanimously approved.
- 9) Discussed lodging for judges and photographer.
- 10) Discussed WCLA Validation Compliance inspection of projects. Will send all info to directors for all species to conduct project checks.
- 11) Discussion on sponsor and sponsorships for 2024 WCLA Show. Need to be more active earlier in the year.
- 12) WCLA spring fundraiser being planned for April 12, 2025. Looking for performing artist for entertainment at Cotton Club. Will most likely include some VIP tickets, steaks and sides, drink coupons, few door prizes along with auction during performer's intermission.

- 13) Discuss selling current 20' Conex containers and purchasing new 40' Conex containers to store pens and gates and box trailer for annual organizational and show office items. Need further discussions with storage location.
 - Colby Doherty made a motion to earmark \$23,400 to purchase 4 – 40' HighCube 1 use Conex boxed with double doors at both ends, contingent on finding storage location. Price includes shipping and tax-free. John Faske seconded the motion. Motion passed unanimously.
 - Will either sell or auction off old 20' Conex boxes as a result.
- 14) There are 57 applications for junior directors. Waiting on replies from AST's on concerns or issues.
- 15) Briefly discussed % per species of auction sale concerning champion buyers funding. Will discuss further in depth at next meeting.
- 16) Distribution of raffle tickets for Fall Fundraiser. Drawing will occur December 13, 2024 and prizes will be awarded the day of sale to the winners. Tickets will be \$25/ticket or 5 tickets for \$100.
