New Business

Motion was seconded by Tim Kleen. Motion passed with a unanimous vote.

Lance Loerwald made the motion that the maintenance of the website change from Steven Romero to Jennifer Hancock for the same pay of \$500.00 per year starting September 4, 2013. Motion was seconded by Kevin Pruess. Motion passed with a unanimous vote.

Tim Kleen made the motion to adjourn. Seconded by Joe Leopold. Motion passed with a unanimous vote.
